1. Delivery Terms

Keyhole

- 1.1 Tenant Screening is available upon acceptance of these terms and conditions. Tenant Screening Plus generally requires that you request access to the product.
- 1.2 If the solution is used without purchasing a credit package or entering into another written agreement, billing will automatically follow the "Pay as you go" prices listed in the current price list.

2. Terms of Use

- 2.1 By using Keyhole Tenant Screening, you agree that:
- a. A completed search cannot be credited.
- b. The system performs a new check each time, so two consecutive searches on the same personal identification number will be billed as two separate searches.
- 2.2 By using Keyhole Tenant Screening Plus, you agree that:
- A product may be invoiced once a tenant has started the process, even if they do not complete it.
- If the tenant does not start the process, no invoice will be issued.
- 2.3 Results are available for 7 days and will be automatically deleted thereafter.

3. Billing and Payment

- Monthly in arrears for the "Pay as you go" pricing model
- In advance for credit packages
- Payment terms are 14 days net, in accordance with the current price list or agreed pricing terms.
